Participating Store	A participating store is any of the 29 off-premise retailer listed in Annexure A in Queensland that stocks Aperol products and displays advertising material for this promotion (each a “Participating Store”). Online purchases from a Participating Store are not eligible for this promotion.
Promotional Period	The Promotion commences on 26 June 2024 and closes for entries at 11:59pm AEST on 23 July 2024 (“Promotion Period”).
Eligible Entrants	Entry is open to Queensland residents only aged 18 years or over. Employees (and their immediate families) of the Promoter, its related entities, Participating Stores, any prize drawers and any agencies associated with this Promotion are ineligible to enter. 	<p>The draw will take place at Greeneagle Distribution & Fulfilment, 5/9 Fitzpatrick Street, Revesby NSW 2212 on 25 July 2024 at 1:00pm. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.</p> <p>5. The first three (3) valid entries randomly drawn will each win a Major Prize, and the next ten (10) valid entries randomly drawn will each win a Minor Prize (each a Prize Winner), as set out below.</p> <p>6. The Promoter may at any time (including after the Promotional Period), verify the validity of entries and entrants and reserves the right, in its sole discretion, to disqualify any individual who the Promoter reasonably believes has breached any of these terms, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Each Major Prize is a Vespa GTS 150 in Bianco Innocenza, valued at \$10,650 including registration, compulsory third party insurance, stamp duty and dealer delivery charges (which may vary State by State) (Major Prize). Additional insurance, options, petrol and all other ancillary costs are the responsibility of the winner.</p> <p>If the winner is, through any legal incapacity or otherwise, unable to register the motorcycle in their own name, then the winner may assign the motorcycle to another person (who consents to such assignment) with legal capacity for the purpose of registration.
